# What personal data we collect and why we collect it

#### Comments

When visitors leave comments on the site we collect the data shown in the comments form, and also the visitor's IP address and browser user agent string to help spam detection. An anonymized string created from your email address (also called a hash) may be provided to the Gravatar service to see if you are using it. Gravatar Privacy Policy. After approval of your comment, your profile picture is visible to the public in the context of your comment.

#### **Contact forms**

We store user input data sent through the contact forms on this website, along with meta information about the submissions, including the time stamp, the origin IP address, and the user agent (browser).

This information will be stored indefinitely and will be used for reference in the event that an email does not reach us due to mail server issues. If you want your information to be removed from our database, please contact us. We will remove it anytime there are concerns about your privacy.

#### Cookies

Most web browsers automatically accept cookies, however you may delete, or disable cookies by following the instructions for your respective browser. Please note that you may not be able to take full advantage of our website if you disable cookies

If you leave a comment on our site you may opt-in to saving your name, email address and website in cookies. These are for your convenience so that you do not have to fill in your details again when you leave another comment. These cookies will last for one year.

If you have an account and you log in to this site, we will set a temporary cookie to determine if your browser accepts cookies. This cookie contains no personal data and is discarded when you close your browser.

When you log in, we will also set up several cookies to save your login information and your screen display choices. Login cookies last for two days, and screen options cookies last for a year. If you select "Remember Me", your login will persist for two weeks. If you log out of your account, the login cookies will be removed.

#### **Embedded content from other websites**

We use Acunetix WP Security to capture live traffic data including meta information such as ip address, user agent, location, and time stamp.

#### Wordfence

We use Wordfence Security to capture live traffic data including meta information such as ip address, user agent, location, and time stamp.

### Popup Maker

Popup Maker uses anonymous cookies to prevent users from seeing the same popup repetitively in an attempt to make user experience more pleasant while still delivering time sensitive messaging. Popup Maker also anonymously tracks popup views and conversions.

#### **Product Related Data**

While you visit our site, we'll track:

 Products you've viewed: we'll use this to, for example, show you products you've recently viewed

- Location, IP address and browser type: we'll use this for purposes like estimating taxes and shipping
- Shipping address: we'll ask you to enter this so we can, for instance, estimate shipping before you place an order, and send you the order!

We'll also use cookies to keep track of cart contents while you're browsing our site. ## Who we share your data with

We share your meta data with Google Analytics and Matamo (Piwik) to help with SEO purposes. PayPal is our payment processor and your personal information is required when paying through their website.

### How long we retain your data

If you leave a comment, the comment and its metadata are retained indefinitely. This is so we can recognize and approve any follow-up comments automatically instead of holding them in a moderation queue.

For users that register on our website (if any), we also store the personal information they provide in their user profile. All users can see, edit, or delete their personal information at any time (except they cannot change their username). Website administrators can also see and edit that information.

## What rights you have over your data

If you have an account on this site, or have left comments, you can request to receive an exported file of the personal data we hold about you, including any data you have provided to us. You can also request that we erase any personal data we hold about you. This does not include any data we are obliged to keep for administrative, legal, or security purposes.

### Where we send your data
